**Test Hours:** 6 AM Eastern Daylight Time until finished. All dogs are to be available at the Test Headquarters by 9:15 am on October 11, 2020 for the Track Drawing. Judging will begin as soon after drawing as the first track is ready.

**Entries Close** – at 6:00 pm on Thursday , October 1, 2020 at the home of the Test Secretary. After this time no entries can be accepted, cancelled or substituted. Drawing for entries and alternates will occur at 6:30 pm the day of closing at the home of the secretary (11160 Ray Rd Gaines, MI). All interested parties are welcome. The drawing of entries will be executed in accordance with CH. 1 Sec 13 of AKC Tracking Regulations.

**ENTRY FEES (in US Funds): \$135.00**  
Includes AKC Fees: an AKC event Service Fee of \$3.00 and a AKC recording Fee of \$0.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This fee is to be collected by the trial-giving club and paid to the American Kennel Club. American Kennel Club rules, CH 11 Sec 2 . Entries not on an official entry form and photo copies of entry forms without Agreement and Rules on the reverse side of the Official entry form are NOT ACCEPTABLE. Entries will not be accepted without fees or signature. A dog entering the Variable Surface Tracking Dog Test must have earned a TD title prior to the closing date of the test. The Test Secretary will give priority to entries for dogs that do not hold a VST title.  
**WORKER DRAW** option as allowed by the AKC Tracking Regulations, Chapter 1 Section 13d will be used in this VST Test. Two tracks will be reserved for workers. A CDTC Worker Certificate must accompany the entry form.  
**ENTRIES** will be acknowledged after closing date with a judging program. Should the exhibitor not receive such acknowledgement within a reasonable time, please contact the Trial Secretary.  
**ENTRY FEES** for alternates who don't participate in the test will be refunded within one week of the completion of the test. Entry fees for dogs which pass an AKC approved test after the closing date of this test will be refunded if they withdraw from this test provided there is an alternate to replace the entry and the Test Secretary is notified in writing not less than 3 days before test date.  
  
Bitches in Season may participate in this test in accordance with CH 2 Sec 8 of the AKC Tracking Regulations. The club may cancel the event in extreme weather conditions. Dogs must be leashed or crated at all times.  
  
**TROPHIES:** Tracking Magnet.
