HANDLING MORE THAN ONE DOG

Chapter 2, Section 10 of the Scent Work Regulations states "Handlers may not handle more than one dog in EACH class (with the exception of Handler Discrimination classes). Multiple dogs from the same owner may be entered in the same class, provided they are run by different handlers."*

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no sign of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

ENTRY FEES

*an entry is defined as a single run by a single dog, in a single class.
Entry fees include a \$3.50 per run AKC recording fee.

No entries will be accepted by phone, email, fax, or hand delivery. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$35.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

Companion Dog Training Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **50 entries per day** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to **February 5, 2021, 6:00pm**. No entries may be withdrawn with a refund after closing on February 5, 2021. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include designated warm-up and waiting area, as well as the secretary table, area for check-ins and posting of running order and results. **Crating will be from your car.** Bring equipment you may need in accordance with the weather conditions.

The **Handler's Briefing.** Judges will conduct a short handler's briefing prior to the start of each class. If it is not feasible to offer the briefing due to the lack of enough space for social distancing purposes of six feet, the judge will give each exhibitor a short handler's briefing at the start line. In the Handler's Briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

ONE labeled container per target odor being used in the trial on that day will be placed in the **Warm-up Area.** This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers in the warm-up area if they choose.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as described in the Scent Work Regulations for each element and class.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. No Scent Work classes or practice will be held on these premises for (2) two weeks prior to the trial.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area, NO SPECTATORS WILL BE ALLOWED IN THE BUILDING AND ARE DISCOURAGED OUTSIDE DUE TO THE REQUIREMENT OF SOCIAL DISTANCING.

CRATING IS OUT OF YOUR CAR FOR THIS TRIAL. NO INDOOR CRATING WILL BE ALLOWED.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Companion Dog Training Club of Flint, MI and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Companion Dog Training Club of Flint, MI reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Companion Dog Training Club of Flint, MI or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Dogs pulled after closing because of injury or other medical condition will be considered for a refund less \$10.00. Notification in writing, on their veterinarian's letterhead, must be given to the trial secretary no later than one-half hour prior to the start of the first class of the day of the trial.

Bitches in season will be considered for a refund less \$10.00. Notification in writing, on their veterinarian's letterhead, must be given to the trial secretary no later than one-half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN:

Once the time for check-in is determined all exhibitors will be notified by email. You will check in at either the Front door (Interiors and Buried) or the Back Door (Containers).

Exhibitors MUST check-in EACH day they are entered.

ARBITRATION

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

COVID INFORMATION AND GUIDELINES

MASKS: Masks are required to be worn in the building at all times. Masks WILL NOT be provided, please be sure to bring your own.

SOCIAL DISTANCING: Practice social distancing at all times. In general, please avoid congregating as much as possible.

SANITAZATION: Wash hands frequently and thoroughly. Use hand sanitizers positioned outside each door and throughout the building. We will clean all commonly touched surfaces regularly throughout each day of the trial and at the end of each day.

RESTROOMS: Restrooms are available in the building, but PLEASE FOLLOW THE DIRECTIONS of the people opening and monitoring the doors. Due to the limits required by the Executive Orders of our State. We are monitoring the number of people in the building at all times.

CRATING: Crating will be out of your car. No crating will be allowed in the building.

PARKING: Please be considerate of your fellow exhibitors. Try to allow for additional space for running your car if needed and for social distancing. We will monitor parking to help exhibitors allow for full use of the parking and to keep all dogs and exhibitors as safe as possible.

FOOD: Please pack your own food and beverages. No food or drink will be available at the trial (except for workers and judges).

SPECTATORS: No Spectators will be allowed in the building. Only judges, workers and exhibitors will be allowed in the building. THERE WILL BE NO EXCEPTIONS.

CHAIRS: Please bring your own chair if you like. They will only be allowed outside. No exhibitor's chairs will be brought into the building during this trial.

RIBBONS: Ribbons **WILL NOT** be self-serve at this trial.

CHECK-IN: Check-in will be outside both doors, depending on the element you are entered in. Containers and Buried will be at the back door. Interiors will be at the front door.

WELCOME & JUDGES INITIAL BRIEFING: Welcome and the judges initial briefing will be outside the back door at the scheduled time. Social Distancing is Required.
