(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (long-haired, smooth wirehaired), Collies (rough, smooth), Bull Terriers (colored, white) Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat) English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles) Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition. Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose Championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog. i.e. age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for a event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. **ENTRY FEES – RALLY and OBEDIENCE** \$29 per dog, per trial for the first entry, \$20 for each additional entry of the same dog per trial. This includes a \$3.50 recording fee for each dog entered, collected by the Show giving club and paid to the American Kennel Club.

- MAIL ALL ENTRIES WITH FEES TO: Karen Rosczewski, PO Box 503, Goodrich, MI 48438
   Entries received without fees, will not be accepted. Entries overnight or Express Mail or other similar services should be designated "No Signature Required".
- ENTRIES WILL BE ACKNOWLEDGED after the closing date with a judging program. Should such acknowledgement not be received by the exhibitor within a reasonable amount of time, please notify the Trial Secretary.
- NO ENTRY SHALL BE MADE and no entry shall be accepted which specifies any conditions of acceptance.
- ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by actions of the Show Committee. If because of riot, civil disturbances or other acts beyond the control of the club it is impossible to open or complete the trial, no refund of entry fee will be made. The club will withhold \$5.00 from the refund for bitches in season.
- EXHIBITORS MUST BE GOVERNED BY ANY RULES OR REGULATIONS of civil authorities and/or building or location restrictions.
- POST-DATED CHECKS AND/OR RETURNED CHECKS do not constitute a valid entry. The Club will add a \$35 collection fee to the amount of each returned check. Subsequent entries from the same exhibitor will result in their being required to pay by cash, cashier's check, or money order. Payment must be received by the entry closing date.
- ERRORS ON ENTRY BLANKS.
